# I. Parliamentary Body

The Parliamentary Body is the core decision-making entity of the GDPSC, composed of 300 members representing nations, regions, demographics, and disciplines.

## Roles and Responsibilities

#### Legislative Functions:

#### Committees:

#### 1. Climate Action Committee

#### **Focus Areas:**

## Responsibilities:

Develop and oversee policies and projects related to climate change; collaborate with international organizations and governments to advance climate goals.

# 2. Environmental Sustainability Committee

#### Responsibilities:

Develop initiatives to foster sustainable economic growth and innovation. Collaborate with businesses, governments, and NGOs to promote green entrepreneurship and job creation.

# 4. Social Justice and Equity Committee

#### **Focus Areas:**

Advocacy for policy change, inclusive dialogue platforms, and community empowerment programs. aiming to promote policies that ensure equitable access to resources and opportunities; supporting marginalized groups in climate adaptation and resilience efforts; creating spaces for diverse voices to participate in decision-making processes.

# Responsibilities:

Ensure that all GDPSC initiatives prioritize fairness and inclusiveness, and Advocate for policies that address social and economic inequalities.

#### 5. Diplomacy in Action Committee

#### Focus Areas:

Modern diplomacy, water diplomacy, trade diplomacy. Aiming to leverage technology and digital platforms to enhance global collaboration and communication; resolving transboundary water conflicts and promoting sustainable water management; building partnerships to advance sustainable investment, green and blue economies, and equitable trade among nations.

#### Responsibilities:

Facilitate international cooperation and partnerships; and address global challenges through diplomatic channels and innovative solutions.

## **Decision-Making:**

Decisions are made through a consensus-driven process, with voting as a last resort. This ensures that all perspectives are considered and that outcomes reflect the collective will of the members.

# II. Diplomatic Corps

The Diplomatic Corps consists of 2,500 diplomats from around the world, serving as representatives and advocates for GDPSC initiatives.

# Roles and Responsibilities:

# Local and Global Advocacy:

Diplomats act as liaisons between the GDPSC and their local communities, governments, states, nations, organizations, promoting sustainable practices and engaging in initiatives that align with the GDPSC's mission.

## **Project Implementation:**

Diplomats play a key role in implementing GDPSC projects and initiatives at the local, national, and international levels.

#### **Global Citizenship initiatives**

Diplomats lead efforts to foster a sense of global citizenship by engaging individuals and communities in sustainability projects, awareness campaigns, and educational programs.

# III. Leadership and Executive Body

The GDPSC is led by a team of dedicated leaders who oversee its operations and ensure alignment with its mission and vision.

#### **Key Leadership Roles:**

#### President:

# V. Decision-Making Process

#### Steps in the Process:

## 1. Proposal Submission:

# 2. Open Debate and Discussion:

Proposals are shared on the GDPSC platform, where members engage in open discussions and provide feedback.

# 3. Expert Review:

# 4. Voting and Approval:

If consensus cannot be reached, proposals are put to a vote. A simple majority is required for approval.

# 5. Implementation:

Approved proposals are implemented by the Executive Body, with support from the Diplomatic Corps and project teams.
