

Privacy Policy and Data Security Framework

I. Introduction

The Global Diplomatic Parliament for a Sustainable Civilization (GDPSC) is committed to protecting the privacy and security of personal data collected from its members, partners, and website visitors worldwide. This Privacy Policy outlines how the GDPSC collects, uses, stores, and protects personal data in compliance with global data protection regulations, including the General Data Protection Regulation GDPR (EU/EEA/UK), CCPA, VCDPA, CTDPA (USA) PIPEDA (Canada), PIPL (China) and other applicable laws.

II. Scope

This policy applies to all personal data collected by the GDPSC, including but not limited to:

- Data collected through the GDPSC website (e.g., membership applications, contact forms).
- Data collected during events, meetings, or partnerships.
- Data shared by members, diplomats, global citizens and partners in the course of their engagement with the GDPSC.

III. Principles of Data Protection

The GDPSC adheres to the following principles when processing personal data:

Lawfulness, Fairness, and Transparency: Personal data is processed lawfully, fairly, and in a transparent manner.

Purpose Limitation:

Data is collected for specified, explicit, and legitimate purposes and not further processed in a manner incompatible with those purposes.

Data Minimization:

Only the minimum amount of personal data necessary for the intended purpose is collected.

Accuracy: Personal data is kept accurate and up to date.

Storage Limitation:

Data is retained only for as long as necessary to fulfill the purposes for which it was collected.

Integrity and Confidentiality:Personal data is processed securely, protecting it from unauthorized access, loss, or damage.

IV. Types of Data Collected

The GDPSC may collect the following types of personal data:

- ✓ Identification Data:Name, email address, phone number, and postal address.
- ✓ Professional Data: Job title, organization, and professional background.
- ✓ Membership Data:Information provided during membership applications, such as age, nationality, and areas of interest.
- ✓ Technical Data:IP address, browser type, and browsing behavior collected through cookies and analytics tools.

V. Purposes of Data Processing

Personal data is processed for the following purposes:

Membership Management: To process membership applications, manage member accounts, and communicate with members and global citizens.

Event Participation: To organize and manage events, meetings, and conferences.

Communication: To send newsletters, updates, and other relevant information.

Website Analytics:To improve the functionality and user experience of the GDPSC website.

Compliance: To comply with legal obligations and regulatory requirements.

VI. Legal Basis for Processing

The GDPSC processes personal data based on the following legal grounds:

- ✓ Consent:Individuals have given clear consent for their data to be processed for specific purposes (e.g., newsletter subscriptions).
- ✓ Contractual Necessity: Processing is necessary for the performance of a contract (e.g., membership agreements).
- ✓ Legitimate Interests:Processing is necessary for the legitimate interests of the GDPSC, such as improving services and ensuring security.
- ✓ Legal Obligations: Processing is necessary to comply with legal or regulatory requirements.

VII. Data Sharing and Transfers

Third-Party Service Providers:

Personal data may be shared with trusted third-party service providers (e.g., IT support, event organizers) who assist the GDPSC in its operations. These providers are contractually obligated to protect the data and use it only for the specified purposes.

International Transfers:

If data is transferred outside from one region to another or from one jurisdiction to other jurisdictions with strict data protection laws, the GDPSC ensures that adequate safeguards are in place, such as Standard Contractual Clauses (SCCs) or adherence to international data protection frameworks.

VIII. Data Security Measures

The GDPSC implements robust technical and organizational measures to protect personal data, including:

- ✓ Encryption: Data is encrypted during transmission and storage to prevent unauthorized access.
- ✓ Access Controls: Access to personal data is restricted to authorized personnel only.
- ✓ Regular Audits: Security measures are regularly reviewed and updated to address emerging threats.
- ✓ **Incident Response:** A data breach response plan is in place to promptly address and mitigate any security incidents.

IX. Data Subject Rights

Under global data protection laws, individuals have the following rights regarding their personal data:

- ✓ Right to Access: Individuals can request access to their personal data and obtain a copy of it.
- ✓ Right to Rectification: Individuals can request corrections to inaccurate or incomplete data.
